

# Rental Conditions



## Rent:

Leasing of motorbikes is dependent on the driver/renter being in possession of a valid MC driver's license. The renting fee includes a driving distance of 200 km's for a day's rent - 500 km's for a weekend - 600 km's for Monday to Thursday – And 800 km's for week.

After which an additional surcharge of 3, -DKK per driven kilometer - not including gas - is added to the price. The bike will have a full tank of gas at pickup and must be returned in the same condition. Missing gas will be added to the bill at the current daily price per liter + 5, - DKK per liter.

The driver/renter is responsible for the condition of the bike, like oil checks, tire pressure etc. the vehicle may not be loaned out, or rented, to a third party

## Insurance:

Comprehensive insurance is included in the rent, there is a deductible of 7500 DKK per instance of parking damage, liability damage, thievery or mistreatment of the bike (scratches, dents etc.) if the damage is of a smaller nature the cost will be adjusted according to the actual price of repair. It is the responsibility of the renter that while the bike is rented, if left it is locked and secure with steering lock engaged. Insurance will not cover damage to the clutch, gearbox, motor, tires or rims. Replacement of tires is not covered by the insurance. Deductible-insurance can be acquired for 75 DKK a day / 3500, - DKK for a month. It is recommended that the client takes photos of the bike at pickup.

## Pick up / drop off:

Pick up is 12 am - drop off at the latest 10 am the day after the end of the rental period.

In consideration of the next renter, it is important that the bike is dropped off at the correct time. If the bike is not dropped off at the agreed upon time, a late fee of 500 DKK is added per started hour, that has elapsed since the time that the bike should have been dropped off. If drop off happens before the agreed upon time, there is no reimbursement. If the bike is not delivered by the agreed upon time, the driver/renter will be liable for damages for the duration of time that exceeds the agreed upon drop of time.

The contract can only be extended via written agreement from Yamaha Store Roskilde ApS Danmark.

## Security deposit:

5.000 DKK when leasing a motorbike.

The deposit will be refunded, at the latest, 10 weekdays after drop off, as long as the bike is returned without damages or scratches, in clean and proper condition. Speeding and parking tickets, as well as other costs incurred by the renter, will be deducted from the deposit. Traffic tickets and the like should be dropped off along with the bike. The administration cost of each incurred ticket is 250 DKK incl. tax per case.

## Cancellation:

If the rental agreement is cancelled, up until 30 days before the start of the agreement, 100% of the deposit will be returned. If cancelling occurs within the period 15-30 days before the start of the rental agreement, 50% of the deposit will be forfeit. If cancelling occurs later than this the renter is liable for the full cost of the rent if the bike doesn't get rented out in the period, the rental agreement would have otherwise run.

## Reservation/ Payment

At the latest, payment will be needed 30 days before the start of the rental agreement. When booking for a time that is later than 30 days into the future, the rent must be payed 30 days before the start of the rental agreement. Payment can happen via debit-card, VISA, Mastercard, American Express. It is also possible to pay in the store via physical attendance

## If accidents occur

If a motorbike breaks down or is involved in an accident, it must be reported immediately to Yamaha Store Ringsted, at +45 57618228 (during opening hours) or +45 26529266 (outside opening hours) – if no one picks up the phone write a text message. If accidents occur after the contract has ended the renter is liable for all damages.

In cases of smaller problems, like flat tires, where help is acquired payment is the responsibility of the driver/renter. Although all bikes come with "SOS international vejhjælp" so the transport back to Yamaha Store Roskilde ApS is covered. Repairs may be carried out ONLY by Yamaha Store Ringsted ApS – unless written otherwise agreed upon with Yamaha Store Roskilde ApS.

### **Accidents and/ or theft:**

In cases of accidents or theft related to the motorbike, the renter is required to:

- a. Immediately report it to the police
- b. Fill out a claims report
- c. Quickly and precisely describe the incident and, and consider whether to note down names of other witnesses
- d. Do not admit guilt or enter into any agreements relating to the incident
- e. Do not leave the vehicle without first taking proper precautions

In case of accidents or theft Yamaha Store Roskilde ApS is not under obligation to offer the renter a replacement vehicle. If a replacement agreement is offered, the renter will have to pay for it anew. New Security deposits must be paid for replacement leases.

### **Unauthorized use of vehicle:**

The renter is obligated to adhere to the abilities of the vehicle while using it, to follow traffic laws and avoid any situations where damage to the vehicle or other people is likely to occur. It is also the responsibility of the renter that no one, other than the renter is handling the vehicle. If accidents occur while a third party is driving, the renter is liable for all damages to the vehicle and other parties involved in any accidents.

In cases of severe lapses in this agreements Yamaha Store Roskilde ApS can charge up to 500 DKK for breaches of the agreement, for each day

Damages sustained to the vehicle's inside and outside parts during unauthorized use is the full responsibility of the renter. The renter is obligated to cover all costs relating to damages sustained in such cases, either via the security deposit or payment in cash, which the renter grants their full agreement to when signing the contract. The renter's signature on the contract is regarded as full agreement to the rental conditions. In cases where payment must be acquired by dept collectors, the renter will also have to pay any lawyer fees in addition to any court fees or other costs relating to court procedures, even if they are not compulsory.

Unauthorized use includes but is not limited to:

- Ignoring warning lights or signals and concerning sounds
- Subleasing
- Utilizing vehicles to pull other vehicles
- Driving in areas that are not suitable for the vehicle, like racetracks, beaches etc.
- Driving with more people than approved
- Driving while tired, exhausted, sick or under the influence of alcohol, narcotics, or medicine
- Using the vehicle after the termination of the contract

- Stickers may not be removed from the vehicle, if this happens the renter will pay the replacement cost.

**Keys:**

if the renter loses the keys, they will be charged the cost of reproducing a new set of keys. It is the obligation of the renter to pay any costs related to the delivery of replacement keys.

**Booking- IMPORTANT!**

- The color of the vehicle may vary from the one shown on pictures
- The machines may be shown with extra equipment – it is not guaranteed that this will be included on your rental, but the machine will as a minimum have standard equipment.

\*If the rental is a superbike, the driver needs to be at least 30 years of age and have 5 years minimum experience.
